New Law Clears Criminal Records

Fast-track Expungement Gets You Back To Work

A significant expungement reform law adopted in 2016 makes it easer than ever to clear court records of non-voilent offenses in Oklahoma.

Lawmakers saw the changes as a way to get people back to work after a scrape with the law.

"I urge anyone eligible for expungement to begin the process as soon as possible," said attorney James Wirth.

"Clearing your court records expands professional opportunities, and it restores a sense of privacy by letting what happened in the past stay in the

Sealing court records can keep a few months probation from becoming a sort of life sentence.

When court records are

expunged, Oklahoma law allows a person to tell employers that they have not been convicted of a crime.

Expungement increases earning potential by expanding access to professional licenses, bonding and security clearances.

Stanford University researchers estimate expungement can increase individual earnings by more than \$6,000 a year.

Because landlords often conduct criminal background checks, sealing court records can mean access to a better house or apartment.

Hunters, collectors and security professionals can restore firearms rights by sealing court records.

Arrest records and DNA samples can be sealed in

an expungement order.

The recent expungement reform reduced the waiting period for many misdemeanor expungements from 10 years to five years. Records in some minor misdemeanors can now be immediately sealed.

Under the new law, additional misdemeanor convictions are no longer an absolute barrier to expungement. Even a second non-violent felony can be expunged after a pardon has been granted in both convictions.

The reform marks the second time in two years lawmakers made it easier to seal records. A 2014 reform enacted language Mr. Wirth had advocated to the Oklahoma Court of Civil Appeals.

that legislators never meant for "I urge anyone eligible multiple charges arising from one incident to be treated as multiple offenses in

expungements. The court disagreed.

After a lawmaker noticed the case, the legislature clarified the law consistent with Mr. Wirth's interpretation.

Because of recent changes, Mr. Wirth recommended that anyone previously denied or ineligible for expungement should review their eligibility.

"We also work with people who were subject to emergency protective orders," Mr. Wirth said.

"If a permanent protective order is not granted, we can ask the court to seal records of the emergency order."

Find Out If You Qualify To Seal Your Court Records

Oklahoma law provides several circumstances in which a person may ask to have court records sealed or deleted including:

- · Immediately after paying a fine of less than \$501 in a misdemeanor conviction that did not involve jail time.
- One year after completing a deferred judgment or suspended sentence in a misdemeanor charge.
- · Five years after completing a sentence in a misdemeanor conviction resulting in jail time or a fine of more than \$500.
- · Five years after completing a deferred judgment or suspended sentence for a non-violent felony charge.

In the categories above, expungement is available if you have not been convicted of a felony and no felony or misdemeanor charges are pending.

Expungement is available after a person first receives a full pardon for their convictions when:

- 10 years have passed after a non-violent felony conviction, if not convicted of a separate misdemeanor in the past 15 years.
- A person has no more than two non-violent felony convictions, and more than 20 years have passed since the most recent felony or misdemeanor conviction.

Immediate expungement is also available for a person acquitted of a charge, whose conviction was reversed on appeal, who was convicted but proven innocent or who was pardoned for an offense committed before they were 18 years old.

Temporary protective orders can be sealed if a permanent order is denied. Arrest records for persons not charged with a crime may be sealed after the time for refiling charges has lapsed.
